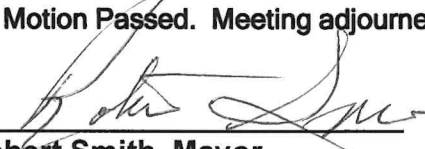
14. ADJOURN
