



# City of Hudson ORDINANCE NO. 20230209

**AN ORDINANCE OF THE CITY OF HUDSON, TEXAS AMENDING PRIOR ORDINANCES PERTAINING TO THE SEWER BASE RATES USAGE CHARGES FOR USERS INSIDE AND OUTSIDE THE CORPORATE CITY LIMITS; MAKING A CHANGE IN SEWER BASE RATES FOR USERS INSIDE AND OUTSIDE THE CORPORATE CITY LIMITS; REPEALING ALL ORDINANCES IN CONFLICT THEREWITH; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUDSON, TEXAS, THAT :**

## **SECTION I : SEWER BASE RATE INSIDE THE CITY AND USAGE CHARGES**

### **Effective March 10<sup>th</sup> 2023**

Sewer Users (INSIDE CITY LIMITS) – The sewer base rate charge will be \$ 18.50 for each residence on the sewer system within the Corporate limits of the City of Hudson, Texas. With \$ 2.00 of the base rate to be designated to Sewer Plant Expansion.

### **Effective January 1, 2024**

Sewer Users (INSIDE CITY LIMITS) – The sewer base rate charge will be \$ 19.50 for each residence on the sewer system within the Corporate limits of the City of Hudson, Texas. With \$ 2.50 of the base rate to be designated to Sewer Plant Expansion.

### **Effective January 1, 2025**

Sewer Users (INSIDE CITY LIMITS) – The sewer base rate charge will be \$ 20.50 for each residence on the sewer system within the Corporate limits of the City of Hudson, Texas. With \$ 3.00 of the base rate to be designated to Sewer Plant Expansion.

## **SECTION II : SEWER BASE RATE OUTSIDE THE CITY**

### **Effective August 1, 2023**

Sewer Users (Outside) – The sewer base rate charge will be \$ 36.00 for each residence on the sewer system outside the Corporate limits of the City of Hudson, Texas. With \$ 2.00 of the base rate to be designated to Sewer Plant Expansion.

### **Effective January 1, 2024**

Sewer Users (Outside) – The sewer base rate charge will be \$ 37.00 for each residence on the sewer system outside the Corporate limits of the City of Hudson, Texas. With \$ 2.50 of the base rate to be designated to Sewer Plant Expansion.

### **Effective January 1, 2025**

Sewer Users (Outside) – The sewer base rate charge will be \$ 38.00 for each residence on the sewer system outside the Corporate limits of the City of Hudson, Texas. With \$ 3.00 of the base rate to be designated to Sewer Plant Expansion.

## **SECTION III : USAGE CHARGES**

### **Effective March 1, 2023**

Usage charges of \$ 2.25 per each 1,000 gallons of water usage at each such residence. Usage charges are calculated at \$ 2.50 per person in each residence until a history can be recorded. Usage is calculated using the months of November, December, January, and February.

## **SECTION IV : CONFLICTS**

Any part of any Ordinance of the City of Hudson, Texas, that is in conflict herewith is hereby repealed.

## **SECTION V: SAVINGS CLAUSE**

If any section, sub-section, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional, void or invalid, the validity of the remaining portions of this Ordinance shall not be affected thereby, it being the intent of the City Council in adopting this Ordinance, that no portion thereof, or provision or regulation contained herein shall become inoperative or fail by reason of the unconstitutionality or invalidity of any section, sub-section, sentence, clause, phrase, or provision of this ordinance.

## **SECTION VI: EFFECTIVE DATE**

This Ordinance shall become effective March 1 2023.
